#### THE DEFINITION OF GENOCIDE

The **1948 UN Convention on genocide** defined the term as any of the following acts **committed with intent** to destroy **in whole or in part**, a national, ethnical, racial or religious group:

#### **KILLING MEMBERS OF A GROUP**

30,878 Palestinians in Gaza have been killed since October 7th. An estimated 70% of those killed have been women and children.\*


#### INFLICTING CONDITIONS INTENDED TO DESTROY THE GROUP

2.2 million Palestinians in Gaza are at imminent risk of famine. 500,000 have reached "catastrophic levels" of food insecurity.\*


WHAT'S HAPPENING IN INTERNATIONAL COURT?

On January 11th and 12th, South Africa took Israel to the International Court of Justice (ICJ) at the Hague, Netherlands on charges of genocide against Palestinians in Gaza.

## IN THE UNITED STATES

THE CASE AGAINST THE BIDEN ADMINISTRATION

### CASE TIMELINE

#### November 13, 2023

Palestinian individuals and human rights organizations filed a complaint with the Biden Administration for failure to prevent genocide

#### November 27, 2023

A "Preliminary Injunction" was filed in attempts to temporarily pause US financial and military support of Israel during the trial of the case.

#### **December 8, 2023**

The US Government moved to dismiss the case.

#### **December 29, 2023**

#### THE IJC DECISION

The official ruling may not come for years, but South Africa asked for a provisional ruling. The ICJ handed down this ruling on January 26th, requiring that Israel let in more humanitarian aid and take steps to prevent genocide, but not calling for a cease-fire. The ICJ rejected a South African request to impose urgent measures to safeguard Rafah in the Gaza Strip on 2/16. The plaintiffs oppose the Biden Administration's dismissal and provide futher evidence of genocide.

#### THE RULING: January 26, 2024

At the 1/26 hearing, the court ruled that they do not have the jurisdictional power over foreign policy matters. U.S. Judge Jeffrey S. White was clearly struck by the case as he allowed the plaintiffs to speak for 3 hours and made a point to highlight the suffering Palestinians are facing at the hands of Israel and the U.S.
